Mr. Rose also addressed the scheduling of a Tri-Board Meeting. He stated that he is in discussion with the TC and BOE Chairs with a plan to schedule the meeting for late January or early February.

9. Status Reports [Financial]:

Mr. Jylkka provided an update on the FY 2017-2018 Revenues, Expenditures and Fund Balance to date.

a) 2016-2017 Revenue

Mr. Jylkka shared that licenses/permits/fees and tax collection (both current and back) continues to be strong further supporting the anticipation of no significant.

b) 2016-2017 Expenditures

Mr. Jylkka shared that there are no significant expenditures to date and that any large percentages spent to date are due to encumbrances. He did, however, make Board members aware of three "unknowns" that could result in some negative impact: 1) legal fees due to contract negotiations (NAGE), 2) Police OT (Injured officer still out), and 3) roof repairs at the Library (reoccurring issue causing damage again).

c) Fund Balance

Current numbers reflect a forecasted ending fund balance over \$100,000 higher than the previous year.

Action Item: Mr. Jylkka to look into an avenue to communicate the positive forecast to the public in order to ease concerns from state cuts.

Action Item: Mr. Jylkka to provide the Board with a status of the safety glass effort at the schools.

10. New Business:

a) Teacher Contract Negotiations

Mr. Jylkka informed the Board that negotiations are scheduled to begin in August with invitations to the Board to participate being promised.

Action Item: Mr. Jylkka to share the policy of what can be discussed in public (BOF meetings) vs. executive session during negotiations.

b) Tax Bill Modification

With the BOE meeting occurring at the same time as this meeting, no report was made. Mr. Rose acknowledged that the expectation is that a Tri-Board meeting will be scheduled once the Budget Policy Statement is distributed.
