1-2. The meeting was called to order, by Chairman Bennington, at 6:30 p.m. followed by the Pledge of Allegiance.

### 3. Public Remarks:

## 4. 2021-2022 Budget Presentations:

Mr. Smith outlined a proposed BOE budget of \$33,182,695\* (a percentage increase of 3.27%) highlighting that this increase reflects "No requests for additional staff" and "No increases to Operational line items (except contractual increases beyond our control)" but does include "Chromebook costs being removed from the Capital Budget and now added to the Education Budget." (full presentation filed with Town Clerk)

Mr. Cox followed by providing an overview of the total budget (Town & BoE) detailing the Town Operations, Debt and Capital portions. A total budget request of \$49,785,828\* which would equate to a Mill Rate increase of 1.59 mills (Mill Rate – 34.73) was proposed. (full presentation filed with Town Clerk)

## 5. 2021-2022 Budget Discussion

Chairman Bennington allowed time for each Board member to make a statement holding questions for the workshops later in the week.

**Chairman Bennington** – While reviewing the budgets, he reflected on investments made over the past year or so and the benefits they awarded the town. He feels this is a rational budget being presented and looks forward to discussions during the workshops.

**Dr. Brown** – While past budgets seemed to be more wish lists, this budget seems to only include necessary expenditures (a barebones budget).

**Mr. Turner** - Concurring with the other members comments, he is encouraged by what he heard and agrees that this is a "lean budget".

**Ms. Coshow** – As always, she is frustrated with the timing and wishes "the unknowns" (state surplus, etc.) were known and could be factored into conversations.
