### 4. 2024-2025 Budget Presentations:

#### **Town Budget**

Mr. Cox provided an overview of the total budget (Town & BoE) detailing the major areas that contribute most to Town Operation increases. A total budget request of \$54,791,257 which would equate to a Mill Rate increase of 3.05 mills (Mill Rate – 39.11) was proposed:

- Town Operations \$ 13,865,946
- Education \$ 38,084,832
- Debt \$ 3,904,329
- Capital/Transfers \$ 1,936,150

  - Pension & Retirement Contribution Increases

### **BOE Budget**

Mr. Smith outlined a proposed BOE budget of \$38,084,832 (a percentage increase of 6.21%) stating that this budget should be looked at as 2024-2025 costs of maintaining the 2023-2024 Budget. With the significant decrease in state funding while state mandates increase, Mr. Smith was happy to share that \$359,333 in savings has been realized from data obtained after this budget was submitted. Changes in health insurance carriers and certified salary adjustments through identified retirements, as well as, transportation and building maintenance cost adjustments are the main contributors to a 5.21% increase of \$37,725,499 instead of the original proposal listed above.
