a. Discussion of 1 Watrous Street:

b. Discussion of 13 Watrous Street/DECD STEAP Grant:

The grant has been closed out. The State accepted the final report. The Town is now eligible to apply for a new STEAP grant.

c. Discussion of 3 Walnut Avenue:

A Phase 2 Evaluation was done on this property in 2006. There was discussion on whether ARPA funds could be used for this property and the Economic Development opportunities for this property.

d. Discussion of 13 Summit Street:

This property is not yet owned by the Town. The original Phase 1 Evaluation was done by the current own so the Town would need to do their own Phase I.

New Grants/Historic Preservation Grants:

The members discussed possibilities for a Historic Preservation Grant and what would be involved including easements on the property. The 3 Walnut Avenue property has a dam on the property that would be considered historic.

The next meeting will focus on a 1-2 year plan with a deeper look at 3 Walnut Avenue.
