#### **Minutes**

# b. Discussion of 13 Watrous Street/DECD STEAP Grant

The well was abandoned. The Department of Public Works consulted with a well driller and filled the well in. The paperwork is being submitted for the \$13,000 payout and closing paperwork. Of the \$500,000 grant approximately \$470,000 was spent.
