They bring solar programs to town and households looking for clean energy solutions. One program is C-PACE (Commercial Property Assessed Clean Energy) is a financing solution that helps businesses with financing green energy solutions to their buildings and company. There is also PPA which means Power Purchase Agreement. This is a contract that consists of two parties; where the first party has the electricity and the second is wanting to buy the electricity. The party looking to buy usually uses a large amount of electricity, such as a school, grocery store, Town Hall, etc. There is a program called Solar For All. This is a partnership between CT Green Bank and PosiGen that brings solar energy and energy efficiency services to homeowners in town. This program is to help increase access to solar energy for homeowners who need and/or want it. These programs and financing

program aim to increase awareness and practice of clean energy solutions to CT towns and homeowners.
