Key items reported on by Mr. Gilmore: Both contact chambers were cleaned and swapped after FST gear box shafts were replaced., The Operators replaced an air release valve in Colchester., Yearly fork truck maintenance was done., Vac truck had valves replaced, Jetter wasn't working properly and the heat exchanger in garage was repaired.

Mr. Paggioli, reported on the status of the Colchester Force Main. The project specs are still pending. DEEP has expressed concerns on traffic flow from the Cranberry Bog to Bull Hill, making certain there will be sufficient signage on the Air line trail prior to and during construction as well as the final restoration piece.

### A. 20/21 Budget Status

Mr. Clayton shared the 20/21FY Revenue & Operations. Revenue and expenses are currently in line for the year with the exception of Vehicle Repairs (5438) which is reporting over at 114.9%. *Copies were distributed and made part of these minutes.*

### B. Plant

A RAS pump needs to be replaced at an estimated cost of \$18,000 to \$20,000. Mr. Gilmore recommends purchasing a Vaughan chopper pump which is estimated at \$18,000.

Per OSHA requirements one (1) set of double doors and one (1) single door needs to be replaced in the inlet building. Quotes are ranging between \$16,000-\$20,000. Mr. Gilmore recommends going with heavy-duty fireproof fiberglass doors.

Mr. Coyle made a motion to authorize \$25,000 for the door replacements and authorize \$25,000 for the replace of the RAS pump, second by Mr. Villa *Vote: 4-0 Motion passed* 

**Roof replacement has been budgeted for 20/21 and 21/22.** Mr. Clayton is recommending doing half in 20/21 starting with the inlet building and half in 21/22. No action was taken on the roof project. Pending solid numbers.
