a. Dry Hydrants Follow Up: Next week Underwater will come out to fix the standpipes in the lake. It will be a two day process. The first day will consist of repairing the dry hydrants at Clark Hill and Raymond Road. The second day would be for repairing Wangonk Trail and American Distilling. Once

everything is finished with those dry hydrants a letter from Jeremy DeCarli would be needed to perform the work on the dry hydrant at the bottom of Chestnut Hill. And the last dry hydrant to be repaired would be at Cobalt Lodge.

- **b. AC upgrades. Status:** Higgins is working on the electrical to be finished.
- **c. Budget Update:** The budget session was held and having the two Tankers in the budget was a funding concern for some of the members of the Town Council. But the financing behind having to replace two Tankers at once showed more savings than if they were bought separately.
- **d. Awards 2020 Update:** An audit was conducted on the awards reports and a few minor changes need to be made. Rick from ACG received the changes and will add them into the blue book reports. There were quite a few more members that qualified this year than previous.
