Old Business and New Business:

Parking Lot & Sidewalk plan is to try for a CDBG in January. Mr. Denman will speak to Town Manager. Ms. Bobbi had asked a contractor to give an opinion if it would be conceivable to do just the drainage before the parking lot. However, this is not an option and we would need to do everything with the parking lot at the same time. Ms. Bobbi noted that she transferred funds from the checking account to the state S.T.I.F. to gain the interest available.

Regarding the issue of "Grill and Gardening Policy", this will be postponed until spring as the summer is over. Ms. McLaughlin would like the Board to look at the Rules and Regulation Policy in the next month or two to see if any additions or changes should be made.

Mr. Denman is interested in obtaining a quote for a fence to replace the damaged, chain link fence along our property line by West Drive.

RSC: Ms. McCarthy has been getting acquainted with the residents and held a matinee for Chatham and Bellwood.
