### IV. COMMUNICATIONS

Town came into markup parking area at Bellwood for sewer line upgrade to neighboring street. This was not communicated to the East Hampton Housing Authority and has significant potential to impact timeline of work on repaving plan and grant work

## V. PUBLIC COMMENT

Kelly Zeitlin read a personal statement voicing concerns regarding covid protocols surrounding the use of the community room.

Kevin Riech informed the board of available federal dollars and suggested they be sought to expand the housing authority's wi-fi capacity.

Kevin, also, suggested we seek grant funding available to purchase land adjacent to Housing Authority property to address the need of low income housing. He understands there is grant funding available.

#### **VI. UPDATES & REPORTS**

#### A. MAINTENANCE PROJECTS

- Paving is currently on hold due to the town sewer replacement project
- Lines at Chatham Acres to be painted next month and will require a coordination of moving cars to allow paint to be applied and dried.
- -E building sidewalk paving is a continuing concern and a plan needs to be developed to remedy it
- Revised Blueprints were made to accommodate changes to the Laundry room design due an accessibility issue. The grant work will be going out as one bid package for a general contractor. This should occur by the end of September
- -C8 has required extensive renovation due to the condition it was left in by previous tenants, All appliances, floors, toilets and sink are in need of replacement.
- -The New inspection process adopted in May 2021 is intended to prevent this negligence in the future.

## **B. RESIDENT SERVICES COORDINATOR**

- Energy assistance packets for the twenty-one/twenty-two heating season, from Community Renewal Team have begun to be received by residents, I will begin meeting with residents to process those in late September
- Rental Rebates are now due, wrapping those up in the next week to get them to the Town Assessor
- Navigating the Bulk Cable transition has been a nightmare due to the cable company

## C. COMMISSION ON AGING

 Their survey is complete and will be distributed at the end of September and available through October. It will be available at the housing authority for residents to fill out, Sheryl will be assisting in that coordination.

- 2. Bids Bellwood Paving Project on hold due to sewer replacement issue.

Bulk Cable - it has been a very bumpy process for residents, but it is moving forward, Sheryl Dougherty is currently working with high level management at Comcast and State Representative Que Phipps Chair of the Commission on Aging to revisit the process to ensure residents best interests have been met as they move forward with their chosen cable packages. If not, needed changes will be made without financial impact to residents.
