SUBJECT: Agenda Information – 4/25/2023

The following is additional or summary information regarding matters on the upcoming Town Council Agenda. The numbering below follows the agenda, and some routine or self-explanatory items are not discussed in this memo. As you review your packet materials, please do not hesitate to contact the appropriate staff member or me prior to the Council meeting with any questions or concerns.

7 Resolutions/Ordinances/Policies/Proclamations

7a Fair Housing Resolution – The Council is asked to adopt this annual resolution updating the Town’s commitment to upholding and enforcing the doctrine of fair housing for all within the community.

Recommendation: Approve the Resolution.

9 New Business

9a Discussion and possible consideration of actions related to the Town’s FY 2024 Annual Budget

- The Council is asked to discuss and consider the proposed fiscal year 2023/2024 Town Budgets for Education and General Government and the Town’s Capital Improvement Plan. The budgets and plan were developed over several meetings including those of the Capital Improvements Committee, the Board of Education, and the Board of Finance. The Board of Finance recommended budget was received by the Town Council prior to its April 11 meeting. The total recommended budget is \$53,603,971, including \$35,608,655 for Education and \$17,995,316 for General Government, which is divided among Town government expenses (\$13,020,881), Debt Service (\$4,122,435) and Transfers/Capital Improvement (\$852,000). The current version of the budget, which is included in the packet, is also posted on the Town website in the Finance Department as the [Board of Finance Proposed FY 2024 Budget](#). When the Council is prepared to approve a budget for referendum, it is asked to set the Annual Town Meeting and referendum dates. Based on the various timelines for notice to the community of the Town Meeting and referendum, a Town meeting could occur two weeks after the determination is made and the referendum could occur one week after the Town Meeting. Once approved, the budget document will be issued as the Town Council Recommended Budget and posted to the Town website. The Council is also asked to consider and approve the Capital Improvements Plan for FY2024 as recommended by the Board of Finance as included in the draft budget. The Council will ultimately need actions to determine the recommended budget amounts, call the Town Meeting, adjourn consideration of the budgets to referendum, approve the Capital Improvements Plan and approve any use of ARPA funds for capital improvements and purchases.

Recommendation: Discuss and determine how and when to move ahead.

9b Discussion and possible consideration of actions to approve the Prevention Partnership Youth Survey – Pursuant to policy, the Council is asked to consider and approve the Prevention Partnership’s Youth Survey, which is taken every two years as a condition of the grant that funds the alcohol and drug use prevention activities of the Town. The survey, which was also approved by the Board of Education earlier this month, includes questions required by the CDC as well as other questions developed locally to help identify local prevention needs and attitudes. Once approved, the survey will be administered to youth in grades 6 through 12 during a school day in May.

Recommendation: Approve the survey.

9c Discussion and possible action regarding participation in the Regional Housing Committee – The Council is asked to determine whether the Town of East Hampton will participate in the Regional Housing Committee, which was created by the Lower Connecticut River Valley Council of Governments (RiverCOG) in follow up to the Regional Housing Plan developed last year among the member Towns, including East Hampton. The Regional Housing Committee is intended to provide a forum for ongoing coordination and collaboration on housing issues among the RiverCOG municipalities that choose to participate with the goal of improving housing diversity and opportunity in the region. The Planning and Zoning Commission reviewed whether the Town should participate in the voluntary Housing Committee and recommended to the Council that East Hampton participate. If the Town will participate, the Council should determine whether the Planning and Zoning Commission, the Town Manager or the Town Council will appoint the Town member. The Town’s member on the Regional Planning Commission is appointed by the Planning and Zoning Commission and it is suggested that the Commission could appoint this member as well.

Recommendation: Approve participation in the Committee and direct the Planning and Zoning Commission to make the appointment.

9d Discussion and possible action regarding the Town Manager’s wage adjustment and contract extension – In follow up to the evaluation undertaken earlier this month, the Council is asked to determine any wage adjustment for the Town Manager in fiscal year 2024. Further, the Council may determine to adjust the term of the Town Manager’s contract, which automatically moves to a year-to-year basis beginning on September 1, 2023.

Recommendation: Determine any wage adjustment, effective July 1, 2023.

The remainder of the items are of a routine nature, in the sole purview of the Council or are announcements. Please contact me or the appropriate staff member with questions or concerns.

Ms. Walck reported that the Department of Public Works assisted at the gazebo by digging up the old plants and spreading topsoil that was donated by Paul's and Sandy's. Park & Rec will be putting down mulch. The Garden Club will be purchasing window boxes for annuals until the final planting is done in the summer.

New Business

Review and Possible Action on an Amendment to the Library Collection Policy

Library Director Tim Kellogg provided an overview of the amendment to the Library Collection Policy, which creates a new section describing policies around Special Collections, including a range of specialized materials from historic documents, original works and works of local authors. The amendment was approved by the Library Advisory Board.

A motion was made by Mr. Goff, seconded by Ms. Walck, to approve the amendment to the Library Circulation Policy as presented. Voted (5-0).

Town Manager's Report

Mr. Cox provided his written report for the Council members which will be included with the minutes filed in the Town Clerk's Office. Mr. Cox called out a few points from the report including:

1. Sewer payment 2nd installments are due by the end of April.
2. The status of the new police vehicle is still unknown. It was thought that a VIN and estimated delivery date were available, but this was incorrect. It is possible the order could be cancelled. The vendor is working on the issue.
3. Library Director Tim Kellogg is leaving on April 24th. The position has been advertised. Mr. Cox thanked Mr. Kellogg for all he has done while working with at the Library.

Mr. Brown asked about the status of the water project. Mr. Cox reported that last week they pulled some final information from the WPCA and are doing the last check of their hydraulic model.

Vice Chairman Feegel asked if the sand was reclaimed at Sears Park. Mr. Cox reported that it was done over the winter.

**FAIR HOUSING RESOLUTION

Whereas, All persons are afforded a right to full and equal housing opportunities in the neighborhood of their choice; and

Whereas, Federal fair housing laws require that all individuals, regardless of race, color, religion, sex, handicap, familial status or national origin, be given equal access to all housing-related opportunities, including rental and homeownership opportunities, and be allowed to make free choices regarding housing location; and

Whereas, Connecticut fair housing laws require that all individuals, regardless of race, creed, color, national origin, ancestry, sex, marital status, age, lawful source of income, familial status, learning disability, physical or mental disability, sexual orientation, or gender identity or expression be given equal access to all housing-related opportunities, including rental and home ownership opportunities, and be allowed to make free choices regarding housing location; and

Whereas, the Town of East Hampton is committed to upholding these laws and realizes that these laws must be supplemented by an Affirmative Statement publicly endorsing the right of all people to full and equal housing opportunities in the neighborhood of their choice.

NOW THEREFORE, BE IT RESOVED, That the Town of East Hampton hereby endorses a Fair Housing Policy to ensure equal opportunity for all persons to rent, purchase, obtain financing and enjoy all other housing-related services of their choice on a non-discriminatory basis as provided by state and federal law; and

BE IT FURTHER RESOLVED, That the Chief Executive Officer of the Town of East Hampton or his designated representative is responsible for responding to and assisting any person who alleges to be the victim of an illegal discriminatory housing practice in the Town of East Hampton and for advising such person of the right to file a complaint with the State of Connecticut Commission on Human Rights and Opportunities (CHRO) or the U.S. Department of Housing and Urban Development (HUD) or to seek assistance from the CT Fair Housing Center, legal services, or other fair housing organizations to protect his or her right to equal housing opportunities.

Good morning Board of Finance members.

My name is Chris Briggs. I reside at 19 Barton Hill Rd. Not only am I a town citizen, but I am also a teacher right here at East Hampton Middle School.

I am writing to you this morning to express my sincere displeasure at your decision to cut the Board of Education budget. This decision is not in the best interest of our town and especially the children in this town. Superintendent Smith has always worked extremely hard to present a budget to the town that is as lean as possible. Having attended many of the BoE budget meetings this year, I saw first hand that the presented budget represents the projected cost to merely *maintain* the current programs that are in place in our schools. Let me tell you - as an educator here in town - while we are all doing our absolute best to teach our children at our current budget level, even the current level is NOT ENOUGH to provide the best for our children.

Our teachers already come to work every single day prepared to "do battle" with resources that are, quite frankly, not enough. Classroom teachers are already being tasked to not only be educators, but also social workers, guidance counselors, therapists, and nurses. To the Town Council:

I am writing to you in support of the East Hampton Ambulance Association budget request for \$176,000 to continue to hire professional EMT staff to fill in some shifts that they cannot fill with their volunteer members. I am writing as an individual, not as Chair of the Commission on Aging, because the COA discussion of this matter will not occur until next week.

Please remember that there are approximately 2,180 adults aged 65 or over in our town. As you know, adults in this age group are understandably very focused on issues of health and disease and are the most common users of emergency ambulance services. Protecting their access to the rapid and reliable services that they now enjoy will bring them gratification and relief. On the other hand, putting their safety and security at risk will create anxiety and resentment.

I have personal experience with their services, as I dialed 911 two years ago when I had chest pain. As a doctor who spent much of my training in the emergency room, I was very impressed with their rapid and high-quality response to my needs. I also know as a doctor that with acute medical conditions such as stroke, heart attack, and hemorrhage, time is of the essence, and delays can be catastrophic.

Therefore I urge you to restore the funding requested by the East Hampton Ambulance Association, which has served our town for decades on a purely volunteer basis, but now needs to fund some shifts with paid EMTs.

The Connecticut Light and Power Company doing business as Eversource Energy (“Eversource” or the “Company”) hereby petitions the Connecticut Siting Council (“Council”) for a Declaratory Ruling that no Certificate of Environmental Compatibility and Public Need (“Certificate”) is required pursuant to Section 16-50g *et seq.* of the Connecticut General Statutes (“C.G.S.”) for proposed modifications to the 1772, 362, 376, and 364 lines that occupy approximately 6.2 miles of an Eversource transmission line right-of-way (“ROW”) that extends generally south-southeast from east of Hurd State Park in the Town of East Hampton, through the Town of Haddam to East Haddam Junction in the Town of East Haddam, as well as minor modifications to Haddam Neck Switching Station (located in Haddam), as described herein, the East of Hurd State Park to East Haddam Junction Rebuild Project (“the Project”).

Eversource submits that a Certificate is not required because the proposed modifications would be within the existing ROW or within Haddam Neck Switching Station and would not have a substantial adverse environmental effect.

2. Purpose of the Project

The purpose of the Project is to replace a total of 58 structures on the four single-circuit transmission lines that occupy the ROW from a location east of Hurd State Park to East Haddam Junction and to replace the existing aged Alumoweld shield wire with optical ground wire (“OPGW”). Forty of the structure replacements are required due to age-related degradation and/or the inability of the existing structures to physically support the new OPGW. In addition, 18 structures will be replaced as opportunity structures, due to their age, in order to maximize the efficiency of age-related structure replacements and forestall a need to complete additional structure replacements in this ROW in the near future. The Project will involve select structure

replacements on the four transmission lines and the replacement of existing static wire with OPGW, as follows:

- **East of Hurd State Park to Haddam Neck Switching Station.** Along this 2.8-mile ROW segment, Eversource proposes modifications to the 115-kilovolt (“kV”) 1772 Line, as well as the 345-kV 362 and 376 lines.
- **Haddam Neck Switching Station to East Haddam Junction.** Along this 3.4-mile ROW segment, Eversource proposes modifications to the 1772 Line and the 345-kV 364 Line.

Eversource also proposes minor modifications within Haddam Neck Switching Station, where the 362, 376, and 364 lines terminate. No modifications at East Haddam Junction will be required. Figure 1 illustrates the location of the Project.

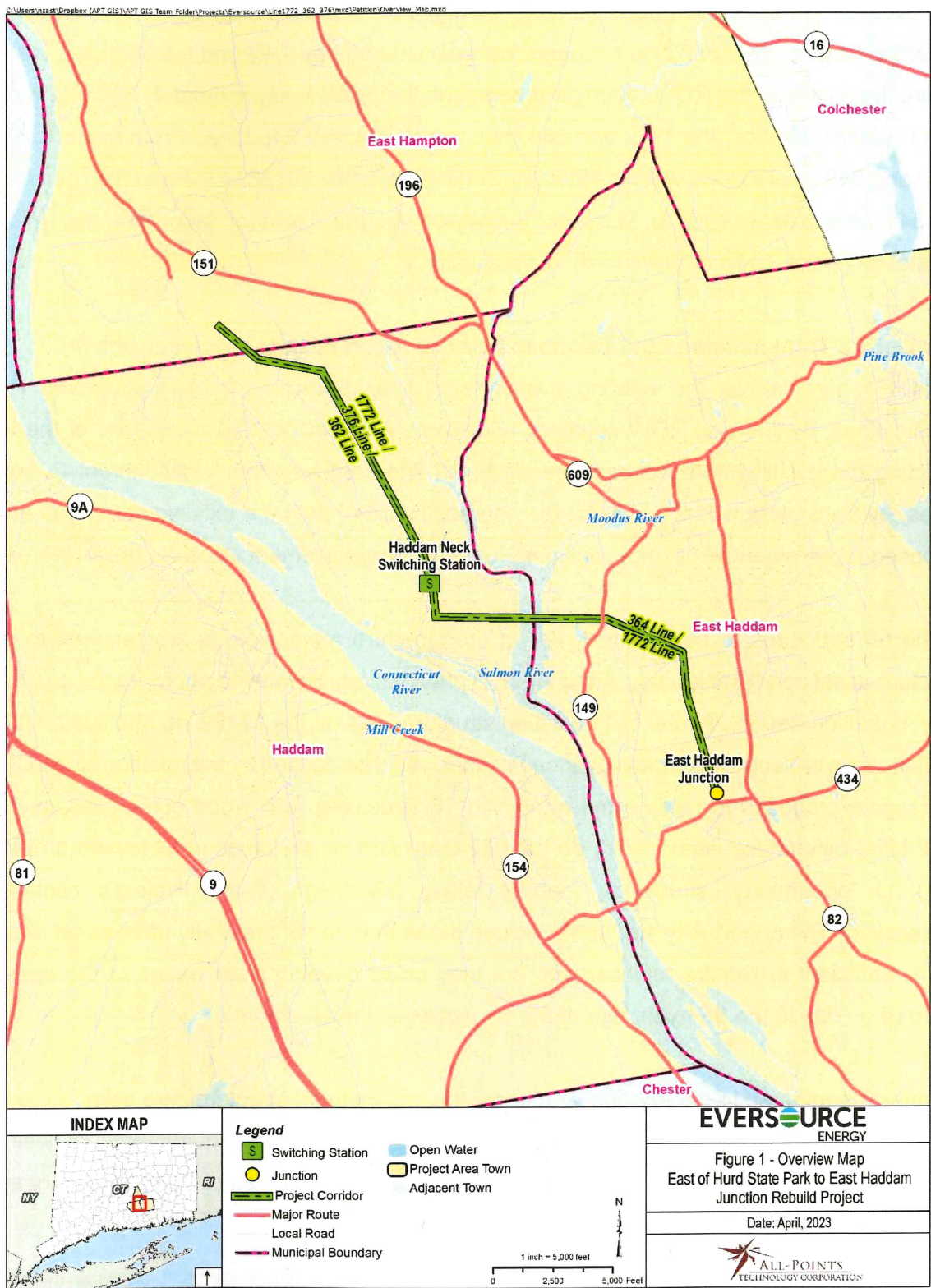
3. Description of the Project Area

As illustrated on the aerial-based map sheets in Attachment A, the approximately 6.2-mile ROW from east of Hurd State Park to East Haddam Junction is situated on both Eversource-owned property and property subject to Eversource easements. Lands in the vicinity consist mostly of undeveloped forest, with some rural residential areas. The ROW, which was established in the early-mid 1960s, extends across various wetlands and small watercourses and spans the Salmon River, which forms the boundary between the towns of Haddam and East Haddam. Approximately 0.3 mile of the ROW is within East Hampton, while 3.5 miles and 2.4 miles traverse Haddam and East Haddam, respectively.

About 2.6 miles of the ROW is located on Eversource property (2.4 miles along the segment north of Haddam Neck Switching Station and 0.2 mile south of the station). Across private property, the ROW is generally approximately 300 to 375 feet wide. Eversource presently manages vegetation along the entire width of the ROW. All proposed structure replacements will be within the managed ROW and, as a result, no forest vegetation clearing will be required for the Project.

From east of Hurd State Park to just north of Haddam Neck Switching Station, the 1772 Line occupies the east side of the ROW, the 376 Line is positioned in the middle of the ROW, and the 362 Line is aligned along the west side of the ROW. Directly north of Haddam Neck Switching Station, the 1772 Line crosses beneath the 376 and 362 lines to the west side of the ROW and continues south outside of and to the west of the switching station.

Figure 1: Project Overview Map



The 376 and 362 lines extend into and terminate at Haddam Neck Switching Station. The 364 Line extends into the station from the south and also terminates there. South of Haddam Neck Switching Station, the 1772 Line occupies the west side of the ROW and the 364 Line is aligned toward the middle of the ROW. Along this segment, the ROW is approximately 300 feet wide. At East Haddam Junction, the 1772 and 364 lines join the 345-kV 348 Line. From the junction, the 1772 and 348 lines extend west to Haddam Substation, while the 364 Line and the remainder of the 348 Line extend east to Montville Substation (in the Town of Montville) and Millstone Substation (in the Town of Waterford), respectively.

4. Existing Transmission Line Facilities and Proposed Project Modifications

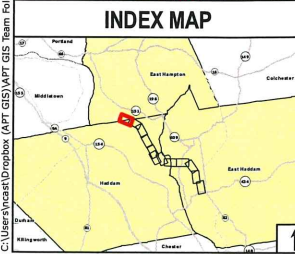
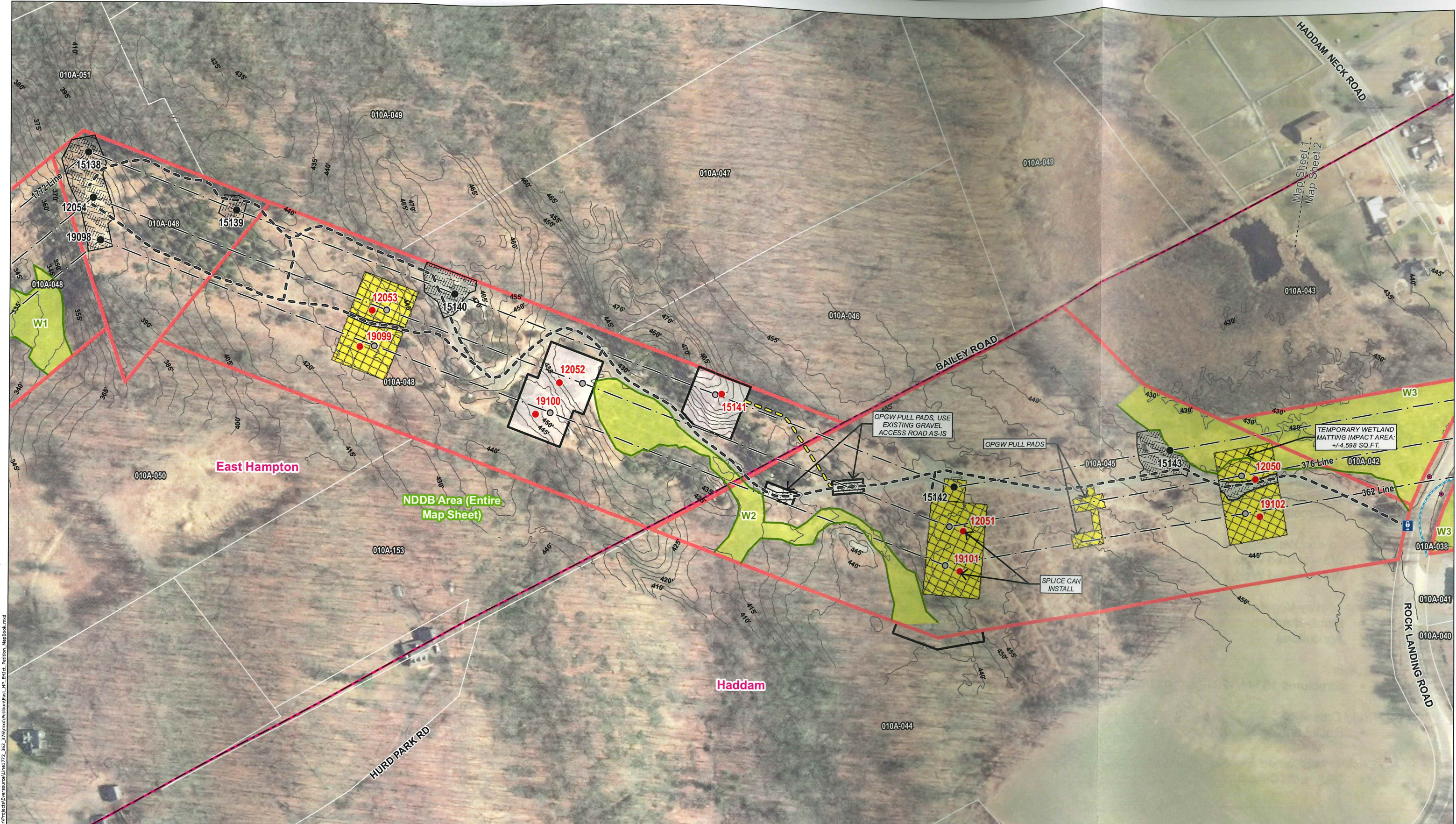
Table 4-1 summarizes the existing transmission line characteristics and proposed Project modifications, by line and ROW segment. Attachment B provides cross-sections of the ROW, depicting the existing and proposed transmission line configurations. Attachment C includes tables, by transmission line, which list the characteristics of both the existing structures and the proposed replacement structures, including reasons for replacement structure height increases.

Of the 58 structures to be replaced, 29¹ of the structure replacements are required to rectify structure asset condition issues. Attachment D provides representative photographs of structure asset condition issues. A total of 11 existing structures (six on the 1772 Line and five on the 364 Line) must be replaced to address overloading that would be caused by the addition of the OPGW. Eversource proposes to replace the remaining 18 structures (two wood pole H-frames on the 1772 Line, nine lattice steel towers on the 362 Line, and seven lattice steel towers on the 376 Line) as “opportunity” structures, thereby taking advantage of the Project’s construction efficiencies. The opportunity structures include those that do not presently have asset condition issues sufficient to require replacement, but they could develop such issues in the near-term future (e.g., due to the 55+-year age of the transmission infrastructure).²

In general, compared to the existing structures, the replacement structures are taller, as required to meet current National Electrical Safety Code (“NESC”) clearance requirements, as well as to meet line-specific engineering requirements to prevent issues such as uplift and insulator swing.

¹ The structures that must be replaced due to asset condition issues include nine on the 362 Line, 11 on the 376 Line, and nine on the 1772 Line.

² None of the existing lattice steel towers on the 376 and 362 lines have been replaced since they were first installed in the mid-1960s. The two opportunity structures on the 1772 Line are wood pole H-frames installed in 1966; these structures have some asset condition issues and are being replaced pro-actively.
