#### 5 Presentations

**5a Presentation from the Commission on Aging regarding the recent survey of Older Adults** – Members of the Commission on Aging will present results and potential follow up activities related to the survey taken of East Hampton's Older Adults in late 2021.

#### 8 Continued Business

**8b Update regarding accepting Fern Lane** – Staff continues to review this matter. Research since the last meeting has focused on land records to understand the origin of Fern Lane and the extensions of it over time. Additionally, as part of the biannual reporting to the State regarding publicly owned roads in the Town, staff is confirming whether Fern Lane or any other roads that have been discussed are roads for which the Town is receiving State assistance for maintenance. Also, staff has engaged in additional review of statutes and other provisions including discussion with the Town Attorney as we consider appropriate options for the Town Council to consider. As noted previously, staff is attempting to consider the private road situation on a global scale with an intent of suggesting Council adopt a formal written policy that pertains to Private Roads and any maintenance or acceptance possibilities the Town is willing to offer. As a footnote to this discussion, Town staff performed minor pothole repair on Fern Lane within the last two weeks. These repairs were undertaken, at Town expense, to prevent damage to the Town's snow plowing equipment during snow removal and ice control activities on the road.

Recommendation: Provide input as necessary and continue the matter.

**8c** Follow up regarding Sustainable CT – The Council is asked to discuss the presentation made by members of the Clean Energy Task Force regarding the Town joining Sustainable CT and to determine whether the Council wishes to enroll the Town in the program. Information from the Sustainable CT

website is included in the packet as is the original presentation. Also included is a proposed resolution authorizing joining and identifying the Clean Energy Task Force as the Town's Sustainability Committee, which is the main action committee under the Sustainable CT program.

Karen Asetta, 5 Fern Lane, commented that it is unfair for the town to expect the homeowners on Fern Lane to act as the developers. They are looking for a mutually acceptable solution to the road issue.

Pam Hatfield, 37 Fern Lane, commented that the primary concern is maintenance for Fern Lane. They want at least the same maintenance as they have received in the past.

Bob Atherton, Main Street, commented on the outstanding job done by the CERT team, police and employees in handing out the COVID test kits and masks. It was very well done.

Mike Piergalini, 16 Fern Lane, commented that Fern Lane needs to be addressed. They expect at least road maintenance. He feels the asphalt estimate that was given at the last meeting was very high. He referred to the Historic District and subdivision regulations.

Mr. Philhower noted that he and Mr. Cox are still working on a solution for this issue, but no decision has been made yet. This item will remain on the agenda.

## New Business

## Easements for Eversource Lines on Gildersleeve Drive and DPW/WPCA Properties

Eversource is asking for two easements to facilitate removal of their poles and wires from the wetland area of the Airline Trail near Gildersleeve Drive to allow the construction of a boardwalk through the area and an access drive to their facilities north of Gildersleeve Drive. Mr. Cox provided an overview of the map of the area.

A motion was made by Mr. Goff, seconded by Mr. Reich, to approve the easements and authorize their execution and filing. Voted (5-0)

## Town Manager Report

Mr. Cox provided an overview of his written report which will be included with the minutes filed in the Town Clerk's Office. In addition to the written report, Mr. Cox reported that the Town held two events for the distribution of COVID test kits and one included the distribution of N95 masks. The Town also provided kits to the Housing Authority, Senior Center, Food Bank, first responders, daycares, town staff and the Board of Education. Approximately 19,400 masks were distributed with about 20,000 still available for residents and businesses. The schools also received test kits and masks separately. Mr. Cox thanked Emergency Management Director Rich Klotzbier, the CERT team and the Lions club for their assistance with the distributions.

## **Appointment of a Poet Laureate**

The Town Council had tasked the Arts & Culture Commission to solicit applicants for the Poet Laureate position. The position has been vacant since the original Poet Laureate, Hugo DeSarro, passed away. The Arts & Culture Commission interviewed three potential candidates and recommended Stan Lindh.

A motion was made by Mr. Reich, seconded by Mr. Goff, to appoint Stan Lindh as the Poet Laureate for the Town of East Hampton with a term of two years. Voted (5-0)

## <u>Tax Refunds</u>

A motion was made by Mr. Goff, seconded by Ms. Walck, to approve tax refunds in the amount of \$11,003.22. Voted (5-0)

## Public Remarks

Pam Hatfield, 37 Fern Lane, commented on the list of private roads from 2014 indicating she thought some roads worse than Fern Lane had been accepted as town roads. She said potholes and maintenance need to be done. She doesn't agree with the Town Manager's suggestion that the residents should pay. All roads in Middle Haddam are narrow. She asks for a permanent resolution to the issue.



## **Transportation Questions**

- Do you own or have easy access to a car?
- What health issues interfere with your driving?
- How do you usually get around town?
- How many times do you leave your home in a typical week?
- Do you think public transportation is: safe, accessible, affordable, convenient, available when needed, adequate for people with disabilities?
- How much difficulty do you have getting to and from outof-town medical appointments?
- Are streets in town well-designed and maintained for pedestrians with adequate crossings?

# **Transportation Responses**

- 97 % own or have access to a car
- 22 % have health issues that interfere with driving-primarily vision, weakness, and arthritis
- 90 % get around town by driving themselves
- 25 % sometimes walk or get a ride from someone (biking is uncommon)
- Rarely do they use public transit, senior van, taxi or Uber
- 12 % leave home less than 3 times a week
- 12 respondents are nearly or fully housebound



## **Transportation Responses**

- Public Transportation
  - 81 % trusted public transportation for safety
  - 69 % felt it to be inaccessible
  - 76 % unavailable when needed
  - 57 % think it is inadequate for those with disabilities (A comment noted that there are no sheltered waiting areas for public transit)



## TRANSPORTATION – Medical Appointments

- Getting to out-of-town medical appointments
  - 3 % have a lot of difficulty (a write in comment noted it is worse in the winter)
  - 11 % have some difficulty
  - 85 % have little or no difficulty
  - 30 % of respondents aged 80 or more had difficulty getting to outof-town medical appointments
  - 32 % with incomes below \$30 k had difficulty getting to out-oftown medical appointments



# Comments on Streets and Crosswalks

- 35 % think streets and crossings are not well-designed or maintained for pedestrians
- 140 comments included:
  - Need for more sidewalks (especially along Rt. 66 and by the lake)
  - Too brief crossing times at intersections
  - Poor Lighting, and Potholes



## Housing Responses

- 58 % prefer a single level private house
- 28 % highly prefer a senior apartment or multi-level senior community
- Accessory Dwelling Units (ADU's)
  - 15 % think they might want an ADU in the next few years
  - 41 % cannot say without further information





# Barriers or Housing Needs

- Barriers include:
  - Lack of available senior housing in EH
  - Lack of affordable housing in EH
  - Current housing = too much maintenance
  - High taxes
- 69 % wanted handicap-accessible living
- 24 % need to make changes to their home to stay there
- Home Modifications needed include:
  - Chair lifts
  - Ramps
  - Walk in shower or tub
  - 1-floor living

## Additional Respondent Comments

- Many concerns regarding East Hampton's water quality
- Desire for public water system
- East Hampton needs more affordable single level apartments:
  - With washer-dryer in apartment and 1 or 2 bedroom
- Create low-income senior housing units
- Property tax break for low-income seniors
- Increasing property taxes are one of the biggest reasons why many of our senior population have had to consider relocating out of our town and/or state

## **Executive Summary of COA Survey**

The East Hampton Commission on Aging surveyed town residents 65 or more years old between 9/17/21 and 10/31/21. The Commission primarily used online SurveyMonkey technology, but also accepted paper surveys. Of the town's 2,160 residents in that age range, 482 (22.3%) filled out surveys. All paper survey responses were transcribed into SurveyMonkey for analysis. All questions except income received at least 400 answers; most received at least 430 answers. The demographics are noteworthy: two-thirds are female, and 27% earned a graduate or professional degree.

#### Housing questions:

- 1. 93% think living independently at home as they age is very important.
- 2. 85% own their housing, and live in a single family house. A quarter are in senior housing, an apartment, or a multi-family house. Nearly a third are overwhelmed by care of the house or grounds.
- 3. 24% need to make changes to their home to stay there. Top comments were: chair lifts, ramps, walk-in shower or tub,1-floor living, and move washer-dryer.
- 4. 24% feel it's very important to stay within 5 miles if they move; 33% feel it's somewhat important.
- 5. Given their health and finances, respondents strongly prefer to stay in their own home, and a majority prefer a 1-level private house. However, a third have a high preference for a senior apartment or a multi-level senior community.
- 6. Barriers to preferred housing were: unavailability in town, unaffordability, and need for too much maintenance. The predominant write-in comments focused on high taxes.
- 7. Most people's ideal apartment or home would have 2 bedrooms, a full and a half bathroom, a separate kitchen, and an open plan living-dining room. 70% wanted handicap-accessible living; many commented on wanting 1 floor living.
- 8. 40% want more information about Accessory Dwelling Units (ADU's)
- 9. 15% think they might want an ADU in the next few years; 41% want more information before deciding.

## Transportation questions:

- 10. 97% own or have easy access to a car.
- 11. 22% have health issues that interfere with driving primarily vision, weakness, and arthritis.
- 12. 90% get around town primarily by driving themselves. A quarter sometimes walk or get a ride from someone; biking is uncommon. Rarely do they use public transit, senior van, taxi, or Uber.
- 13. Only 12% leave home less than 3 times a week, but 12 people are nearly or fully housebound.

- 14. Public transportation is mostly trusted for safety (80%), but felt to be inaccessible and unavailable when needed; nearly 60% think it is inadequate for those with disabilities. A comment noted there were no sheltered waiting areas for public transit.
- 15. 85% have little or no difficulty getting to out of town medical appointments, but3% have a lot of difficulty; write-in comment noted it's worse in winter.
- 16. 65% think streets and crossings are well-designed and maintained for pedestrians. 140 comments were mostly about the need for more sidewalks, especially along Rt. 66 and by the lake. Also mentioned: too brief crossing times at intersections, poor lighting, and potholes.

## Healthcare and affordability questions:


- 17. 31% note an unmet need for safe walking nearby. Over 20% each have unmet needs for each of the following: wellness classes, fitness classes, local health info, home care services and providers, and specialty care providers.
- 18. 93% are fully vaccinated for Covid-19; 7% answered "no" or "prefer not to say."
- 19. Primary sources used for news and current events are local news and Rivereast, followed by TV news, social media, and the Senior Center; write-ins mostly cited national newspapers and Hartford Courant.
- 20. Nearly 20% do not think they will be able to support themselves in retirement.
- 21. 23% feel they will have to work in retirement due to finances.
- 22. 19% think they cannot afford to stay in East Hampton during retirement.
- 23. 40% feel lonely at least occasionally; 3% feel lonely often.
- 24. In the past year, 9% worried that food would run out without money to buy more.
- 25. In the past year, 7% actually did run out of food, and had no money for more.

## Demographics and final questions:

Note: 424 or more answered each demographic question except for income - only 379 answered.

- 26. A majority find East Hampton a fair (42%) or poor (12%) place to live as they age.
- 27. Two-thirds of respondents identify as female.
- 28. Two-thirds of respondents are from 65 to 74 years old. 18% are over 80 years old.
- 29. 1% Hispanic, Latino, or Spanish origin
- 30. 98% White
- 31. Education varied widely, with 80% trained/educated post-high school, and 27% with a graduate or professional degree.
- 32. 57% married, 39% divorced/separated/widowed, 3% never married.
- 33. Annual income before taxes in 2020 ranged widely with a median of \$50,00 to \$75,000; 12% earned less than \$20,000, and 22% earned from \$20,000 to \$40,000.

## Q1 1. How important is it to live independently at home as you age?







# Q9 Does an Accessory Dwelling Unit sound like an option that you might use in the next few years?









# Q20 Will you be able to support yourself in retirement?





# Q21 Will you have to work in retirement due to finances?






# Q23 How often do you feel lonely?




# Q25 Past year, how often did food RUN OUT while out of money?


# Q26 Rate East Hampton as a place for people to live as they age:


# Q27 What is your gender?


# Q28 What was your age in years at your last birthday?


# Q29 Are you of Hispanic, Latino, or Spanish origin?







# Subgroups Summary of COA Survey

The East Hampton Commission on Aging survey of older adults' needs was analyzed as a whole and reported separately in the document entitled, "Executive Summary of COA Survey." That report focused on ALL responses taken as a whole (e.g., the entire Venn diagram); this report focuses on specific groups of respondents (several circles within that diagram) chosen for their possible unique needs.

Each group was compared to the whole for every question. For questions that the group answered differently from the whole, that difference is summarized, and listed as "(% of group v. % of whole)." At the end of each group report is a list of question numbers for which the group and the whole agreed closely.

**Validity of incomplete surveys** 482 people submitted surveys, of which SurveyMonkey judged 413 to be complete. For all questions and all of their subparts, both groups of responses were statistically essentially identical. Thus the 69 incomplete responses can be tallied as valid responses.

### A. 80 years old or over: 78 responses

### Housing:

Many of our growing population of seniors have resided in and have supported East Hampton for a number of years. I feel that consideration should be given for some sort of tax relief. Seniors subsist on a fixed income. We are willing to pay our fair share and have done so for a many years. However, increasing taxes are placing an undo burden on the seniors of our town. Increasing taxes are one of the biggest reasons why many of our senior population have had to consider relocating our of our town and state.







### Resolution Supporting Participation In the Sustainable CT Municipal Certification Program

WHEREAS, Sustainable CT is a comprehensive, statewide, action-oriented voluntary certification program, built by and for municipalities, with the vision that: *Sustainable CT communities strive to be thriving, resilient, collaborative, and forward-looking. They build community and local economy. They equitably promote the health and well-being of current and future residents. And they respect the finite capacity of the natural environment.* 

WHEREAS, Sustainable CT is designed to boost local economies, help municipal operations become more efficient, reduce operating costs, and provide grants and additional support to municipalities.

WHEREAS, the Town of East Hampton embraces an ongoing process of working toward greater sustainability, selecting which actions it chooses to pursue from the voluntary menu of actions provided by Sustainable CT.

RESOLVED, by the Town Council of the Town of East Hampton that we do hereby authorize the Town Manager, or designee, to serve as the Town of East Hampton's Sustainable CT contact person for the Sustainable CT Municipal Certification process and authorize him to complete Municipal Registration on behalf of the Town of East Hampton.

RESOLVED, that to focus attention and effort within the Town of East Hampton on matters of sustainability, and in order to promote the East Hampton Town Council's local initiatives and actions toward Sustainable CT Municipal Certification, the East Hampton Town Council revises the role of the Clean Energy Task Force to serve as a Sustainability Team.

RESOLVED, that the first meeting of the Sustainability Team must be held within 90 days of passing this resolution and that the Sustainability Team shall meet as frequently as needed, but no less than quarterly.

RESOLVED, that the Sustainability Team shall report annually to the East Hampton Town Council on the progress of its activities toward Sustainable CT certification, with reports and presentations made publicly available.
