The following are the final specifications and standards. The site is the Applicant's private riding arena adjacent to his personal residence. It is for the use and enjoyment of the Applicant and his family.

- 1. The Application is for 6 recycled telephone poles at the locations shown in the plan which have not changed during the Application review process. A full property survey was introduced at the April 3, 2024, public hearing.
- 1. The fixtures will be set at 17 feet. (This is a reduction from the original proposal which was twenty feet.)
- 2. The test conducted on the nights of April 24 and 25, 2024, was at 17 feet using the exact fixture at one of the side poles.
- 3. A copy of the exact fixture and technical details are attached hereto (2 pages). The fixture is fully covered, as requested by the Commission.
- 4. No permit is required from the Connecticut Department of Transportation regarding the lighting subject of this Application. See the Applicant's letter to the Commission attached hereto.


