Re: Update to Official Zoning Map

In reviewing the latest Zoning Map as part of the update to capture the latest Zone Changes, Staff reviewed all Zone Change decision beginning in 1990 in order to verify that the map was accurate. The numbers in circles on the map correspond with the changes below.

This map reflects the latest changes:

1. 27 Flanders Road	R-4 to R-1	Approved 9/4/2019
2. 35 West Point Road	R-1 to C	Approved 11/6/2019
3. 49 Oakum Dock Road	R-2 to C	Approved 12/4/2019

In addition to the above, Staff has found the following Zone Change approvals that have not been reflected on the map:

4.	6 & 8 Skinner Street	I to VC	Approved 1/6/1993
5.	116 & 122 Middletown Avenue	I to R-2	Approved 10/27/1993
6.	11 Hog Hill Road	R-2 to C	Approved 9/5/2001

Next, staff recommends considering the following changes to more accurately reflect current conditions which are broken down on the list on the following page:

220 Tartia Road	R-4 to RL	Transferred to NFWS
Comstock Trail Open Space (4pcs)	R-4 to RL	Private Owner, Conservation
Middlesex Land Trust (16 pcs)	Various to RL	Conservation Lands

Finally, it was discovered that four parcels, 44, 68, & 88 Long Crossing Road (2 parcels) were approved for a change from R-2 to Commercial on August 2, 2006 for the purpose of constructing the Village at Long Crossing. No approval was ever given for the proposed active adult community, and the largest parcel (88 Long Crossing) was recently sold and a single family home was constructed. It is the recommendation of Staff that these parcels be officially redesignated as R-2. If the Commission chooses to do so, Staff will notify the property owners as required.
