Approval of Construction Management Services for Police Department/Town Hall/Board of Education Facility

Town Manager Report

State Revenue Projections

Town Manager Maniscalco heard this afternoon that East Hampton is looking at a reduction of about 1.6 million dollars. There are a number of different sources that can help offset a revenue loss of up to 3.7 million, which includes the .44 mills that was previously built into the budget for \$495,000.

Update on Certified Local Government

More information on the grant will be emailed by Ms. Dunn of the SHPO. The review and application process could potentially be onerous for Town staff. There was discussion about potential hardships for private property owners of buildings that are determined to be historic. Ms. Dunn believes the distinction could open up funding for saving some of the buildings; this is not intended to stand in the way of renovations of demo. Councilor Piteo asked for another review of the pros/cons document previously distributed.

Update on Tax Sale

The tax sale has been put into action; demand letters have been issued to the top 30 delinquent tax payers.

Town by Town Article

Mr. Maniscalco noted that in the article from Hartford Magazine, East Hampton is listed in a few instances, and is ranked as the third most affordable town in terms of property tax.

Update on Replacement of Bridge on Route 66 Over Pocotopaug Creek

The bridge in front of American Distilling will be replaced in the Spring of 2019. Because the DOT has determined there are soil contaminants, time will need to be added to the project. Rather than closing Rt. 66 for 7 days, it will now need to be closed for 14 days.
