The Annual Town Budget Meeting of the electors of the Town of East Hampton and those entitled to vote at town meetings was held on May 23, 2023 at 6:00 p.m. at the East Hampton Town Hall Council Chambers at 1 Community Drive, East Hampton, CT.

Kelly Bilodeau, Town Clerk called the meeting to order at 6:00 p.m. Ms. Bilodeau called for a motion to appoint a moderator for the meeting. A motion was made by Mark Philhower and seconded by Brandon Goff to appoint David Cox as the Moderator. Hearing no objection, a vote was taken, and the motion was passed unanimously.

Moderator Cox read the Charter requirements and skipped the reading of the legal notice for the meeting stating that it is published in the Rivereast Newspaper.

There were 10 electors present at the meeting. Moderator Cox called for questions. Hearing no further discussion, the Annual Town Budget Meeting was adjourned at 6:02 p.m. to the Referendum on Tuesday, May 30, 2023 from 6:00 a.m. to 8:00 p.m.
