The Special Town Budget Meeting of the electors of the Town of East Hampton and those entitled to vote at town meetings was held on June 27, 2023 at 6:00 p.m. at the East Hampton Town Hall Council Chambers at 1 Community Drive, East Hampton, CT. There were 15 electors present at the meeting.

Alan Hurst, Moderator called the meeting to order at 6:15 p.m. Moderator Hurst stated that in accordance with section 4.1 of the Town Charter and Town practices, the purpose of the meeting was to meet and adjourn to a referendum by paper ballot on the questions related to the Town's annual budget. There was no discussion or action to be taken regarding the budget itself at this meeting. He further stated that notice regarding the call of the meeting was properly placed at the Town Clerk's Office and published in the Rivereast newspaper on Friday, June 16 in accordance with the requirements of state law.

Moderator Hurst called for questions. Hearing no further discussion, the Annual Town Budget Meeting was adjourned at 6:16 p.m. to the Referendum on Tuesday, July 11, 2023, from 6:00 a.m. to 8:00 p.m.
