

# Town of East Hampton Annual Town Budget Meeting Monday, May 13, 2019 East Hampton Town Hall Meeting Room

The Annual Town Budget Meeting of the electors of the Town of East Hampton and those entitled to vote at town meetings was held on May 13, 2019 at 6:00 p.m. at the East Hampton Town Hall Meeting Room at 20 East High Street, East Hampton, CT.

Moderator Mr. Steven Greco opened the meeting at 6:00 p.m. and read Attachment #1 - Town Meeting Information. Moderator Greco then directed Town Clerk Kelly Bilodeau to read Attachment #2 — Town Meeting Call.

Following the reading of the call Melissa Engel read Attachment #3 - Town Meeting Resolutions as follows:

Resolved, that this Town Meeting sets the date of Tuesday, May 21, 2019 from 6:00 a.m. to 8:00 p.m. for a referendum by "YES" OR "NO" vote on voting machines for approval or disapproval of the Town Government annual budget for fiscal year 2019-2020 as recommended by the Board of Finance and approved by the Town Council.

Further resolved, that this Town Meeting sets the date of Tuesday, May 21, 2019 from 6:00 a.m. to 8:00 p.m. for a referendum by "YES" OR "NO" vote on voting machines for approval or disapproval of the Board of Education annual budget for fiscal year 2019-2020 as recommended by the Board of Finance and approved by the Town Council.

Moderator Greco declared, there being no further business the Town Meeting was adjourned at 6:03 p.m. to the Referendum on Tuesday, May 21, 2019 from 6:00 a.m. to 8:00 p.m.
