BOARD AND COMMISSION SUMMARY JULY 2018

Arts & Culture Commission

East Hampton Arts & Culture Commission met on July 19, 2018 at the Joseph N. Goff House. The commission will host a Theater Chat with Wade Russo, the summer musical director at the Goodspeed on the influence of politics on the American musical on Tuesday, Aug. 14 at the East Hampton Public Library. The Art Open House/Open Studio is tentatively planned for Oct. 28 with an artist open house from 3 to 5 p.m. on Sept. 22 at the Goff House to invite local artists and discuss ideas. There are currently two vacancies with three terms coming up in December.

Board of Finance

During the Month of July, The Board of Finance met on 3 separate occasions: Monday July 16th (Regular Meeting), Monday July 23rd (Special Meeting) and Wednesday July 25th (Special Meeting).

With the focus of all 3 meetings being discussion and recommendation on the 2018-2019 Budget for Town Council (3rd referendum), the Board did put forth a Budget for the Council on July 25th that included:

- No change to the Town Operations Budget (from the 2nd referendum)
- A \$91,000 Capital Budget reduction (from the 2nd referendum) coupled with an appropriation recommendation from the unassigned General Fund Balance to address the project
- No change to the Debt Service Budget

Brownfields Redevelopment Agency

The Brownfields Redevelopment Agency held a special meeting on July 5th. The well driller is attempting to install the treatment system at the house near 13 Watrous Street. Mr. Maniscalco updated the agency on town business.

The Brownfields Redevelopment Agency held their regular meeting on July 30, 2018. They received an update from the Town Manager on projects. The members discussed their bid documents for the DECD STEAP grant project. They want everything completed for the bid documents collected to see what needs to be finished. The members will figure out whether the project will start in the spring or the fall depending on the bod documents and the bids that may come in once the documents go out. There was an update for the 1 Watrous Street property for the members. The members affirmed the bylaws and are keeping the same officers and will hold another election once more members join the committee.

Clean Energy Task Force

The Clean Energy Task Force held a special meeting on July 24th. The Clean Energy Task Force Facebook page is up and being shared on different East Hampton sites. The Green Car Show will be held on September 8th (rain date September 9th) at Sears Park. Updates were provided on the various dealerships participating in the event. A prospective project

to assist low and middle-income residents to a conversion to a mini-split system was discussed.
