Sub-Committee Reports & Updates

Mr. Cox reported that there is information in the Town Manager's Report from the sub-committee.

Mr. Reich reported that the tennis court cracks will be repaired under warranty. There will also be discussions regarding an extension of the warranty to confirm the tennis courts will remain in the expected condition. Mr. Philhower would like Mr. Cox to find out what type of repairs were needed.

Mr. Reich also reported that members of the Middle School Roof Committee met with the administration and the Department of Administrative Services to review the packet that will go out to bid.

Mr. Philhower did a walkthrough of the Middle School for repairs. Mr. Fontanella will review the skylights to see if they will remain or will be removed during the roof replacement. They will also be moving the condensers on the roof during the construction.

Discussion on 2023-2024 General Government & Board of Education Budgets and Capital Plan

Town Council members reviewed the answers to multiple Town and Board of Education budget questions they submitted prior to the meeting. The detailed documents will be included with the minutes filed in the Town Clerk's Office.

Possible Action on 2023-2024 General Government & Board of Education Budgets and Capital Plan

A motion was made by Mr. Goff, seconded by Mr. Feegel, to include the too high/too low questions on the ballot. Voted (7-0)

A motion was made by Mr. Goff, seconded by Mr. Peterson, to approve the Fiscal Year 2023-2024 General Government budget in the amount of \$17,900,137 which includes the following reductions: \$3,277 from Town Hall Building Maintenance, \$1,902 from Collector of Revenue Other Purchased Services, \$20,000 from Transfer Station and \$30,000 from the Lieutenant position. Voted (3-4) Mr. Philhower, Mr. Goff and Mr. Peterson in favor; Mr. Brown, Mr. Reich, Ms. Walck and Mr. Feegel against.

A motion was made by Mr. Goff, seconded by Mr. Peterson, to approve the Fiscal Year 2023-2024 Board of Education budget in the amount of \$35,608,655 as presented by the Board of Finance. Voted (4-3) Mr. Philhower, Mr. Goff, Ms. Walck and Mr. Peterson in favor; Mr. Brown, Mr. Reich and Mr. Feegel against.

A motion was made by Mr. Goff, seconded by Mr. Peterson, to approve the motion for a Town Meeting to be called for Tuesday, May 23 at 6:00pm in the Town Hall for the purpose of considering the 2023-2024 Board of Education budget and to immediately be adjourned to a referendum vote on Tuesday, May 30 in accordance with Charter Section 4.1. Voted (4-3) Mr. Philhower, Mr. Goff, Ms. Walck and Mr. Peterson in favor; Mr. Brown, Mr. Reich and Mr. Feegel against.

A motion was made by Mr. Goff, seconded by Mr. Peterson, to approve the Fiscal Year 2023-2024 Capital Improvements Plan in the amount of \$809,500 contingent on final determination of ARPA funding. Voted (5-2) Mr. Philhower, Mr. Goff, Mr. Feegel, Ms. Walck and Mr. Peterson in favor; Mr. Brown and Mr. Reich against.

A motion was made by Mr. Peterson, seconded by Ms. Walck, to approve the Fiscal Year 2023-2024 General Government budget in the amount of \$17,995,316 as presented by the Board of Finance. Voted (4-3) Mr. Philhower, Mr. Goff, Mr. Peterson and Ms. Walck in favor; Mr. Brown and Mr. Reich and Mr. Feegel against.

A motion was made by Mr. Goff, seconded by Mr. Peterson, to approve the motion for a Town Meeting to be called for Tuesday, May 23 at 6:00pm in the Town Hall for the purpose of considering the 2023-2024 General Government budget and to immediately be adjourned to a referendum vote on Tuesday, May 30 in accordance with Charter Section 4.1. Voted (4-3) Mr. Philhower, Mr. Goff, Ms. Walck and Mr. Peterson in favor; Mr. Brown, Mr. Reich and Mr. Feegel against.

New Business

Discussion and Possible Action on 2023-2024 Schedule of Fees and Charges

Mr. Cox provided an overview of the proposed changes to the Schedule of Fee and Charges.

A motion was made by Ms. Walck, seconded by Mr. Peterson, to approve the 2023-2024 Schedule of Fees and Charges removing the .26 increase to Building Permit Fees for the State Education Fee. Voted (6-1) Mr. Reich against.

Town Manager's Report

Mr. Cox provided his written report for the Council members which will be included with the minutes filed in the Town Clerk's Office.

Appointments

Conservation-Lake Commission

John Purple of the Conservation-Lake Commission has requested to be moved to an alternate member at this time.

A motion was made by Mr. Goff, seconded by Mr. Reich, to move John Purple from a full member of the Conservation-Lake Commission to an alternate member and to move Jay Hartling from an alternate member of the Conservation-Lake Commission to a full member. Voted (7-0)

CT Yankee Fuel Storage Advisory Committee

A motion was made by Mr. Goff, seconded by Mr. Reich, to appoint Peter Strickland to the CT Yankee Fuel Storage Advisory Committee. Voted (7-0)

Tax Refunds

A motion was made by Ms. Walck, seconded by Mr. Reich, to approve tax refunds in the amount of \$1,348.85. Voted (7-0)
