1. Budget Status FY 23/24

Mr. Clayton reported on the 23/24 budget. WPCA revenue is reporting at 67.2% and operating expenses are reporting at 45.4%.

23/24 revenue collected from water customers for Town Center and Royal Oaks is reporting at 30.2% and 39.9% respectively and Operations is reporting at 34.7% spent for Town Center and 33.4% spent at Royal Oaks. *Copies distributed and made part of these minutes.*

Mr. Barmasse asked if the funds used for the municipal water study was refunded back to the water department. Mr. Clayton will check with finance.
