A. Joint Facilities

No Regular Joint Facilities meeting. Mr. Clayton reported that there was another force main break in Colchester off River Road (*approx. a half mile west of river road, 300 feet east of the Blackledge river crossing*) on the Airline Trail. A pipe blew out of the T and broke the collar and mechanical joint. The T was capped and repaired relatively quickly.

Rain flooded multiple stations on Christmas Eve and Christmas Day. The operators used the Vactor truck and were able to stay on top of the flooding.

B. Operations, Management & Budget Committee

1) Budget Status FY 2020/21

Mr. Clayton reported on the 20/21 budget. Revenue for WPCA sewer bills is reporting at 73.7%. WPCA Operations is running high under 5430 from the repairs at Laurel Ridge (CSI control panel, conduits and junction box) the cost maybe be incorporated as a Capital Item at the end of the year. Also, under 5690 from the hydraulic oil spill at Royal Oaks.

Revenue collected from water customers for Town Center and Royal Oaks is running behind at 32.2% and 41.3% respectively. The reduced interest rate option on delinquent revenue payments mandated by Executive Order 2020-7S due to the Covid-19 pandemic is still in place. This is low interest rate program at a rate of .25% for taxes, water and sewer bills. *Copies distributed and made part of these minute*.
